Update - CMS Initiative to Improve Behavioral Health and Reduce the Use of Antipsychotics Medications for Nursing Home Residents

The Technical Expert Panel Meeting was held in Baltimore, MD on 4/10/12-4/11/12 and GAPNA was represented. The purpose of this meeting was to bring together subject matter experts to have task-oriented discussions around the following four topic areas:

- Non-pharmacological interventions in dementia
- 2. Focus on the Survey Process
- 3. Medication Management (including F329)
- Quality Assessment and Performance Improvement (QAPI) Principles

The four workgroups developed detailed outlines and ideas for 2 training sessions for surveyors, and also discussed ideas for future trainings for providers, consumers and others.

At the present time, GAPNA can support this initiative by:

- 1. Encouraging members to <u>view the CMS webcast</u> on the initiative. State and federal nursing home surveyors will be looking for documented evidence of the use of non-pharmacological interventions to treat nursing home residents with dementia and behavioral symptoms, in addition to efforts made to reduce the use of antipsychotics in this population.
- Encourage those working in nursing home settings to review F Tag 329 as this is how the surveyors will be evaluating the use of antipsychotics in nursing home settings.

CMS Releases Final Rule on Hospital Conditions of Participation

The Centers for Medicare & Medicaid Services (CMS) has released its Final Rule on Reform of Hospital and Critical Access Hospital Conditions of Participation.

Reformed provisions of the rule include expansion of the term "medical staff" to include practitioners such as APRNs and PAs, options for hospitals to implement programs for patient self-administration of some medications, and support for the use of team-based and collaborative care for patients. It also references the IOM report and touches on the report's themes. CCNA's summary of its major provisions can be found here: http://championnursing.org/CMS-CoPs-5-10-12. CCNA continues to review the rule and will provide an updated analysis as necessary.
