New Drugs - Dementia & Alzheimer's Disease Dr. Liam Fry, MD, CMD, FACP

Dr. Liam Fry is board-certified in hospice and palliative care, geriatric medicine, and internal medicine. In addition, she is the division chief of geriatrics and palliative medicine and has an appointment by Gov. Greg Abbott to the Nursing Facility Administrator Advisory Committee. She coordinates recurring volunteer opportunities for her practice at the Austin Geriatric Practice with Capital Area Food Bank and serves as a volunteer in the Travis County Medical Society Athletic Physicals Outreach. Dr. Fry has demonstrated a passion for helping other physicians grow their medical director skills and has worked to educate her fellow physicians in this area.

#### **Sleep and Cognitive Implications**

#### Kathy Richards, PhD, RN, FAAN, FAASM

Dr. Kathy Richards' research focuses on improving sleep and related symptoms, such as nighttime agitation, and memory in older adults with mild cognitive impairment and Alzheimer's disease. Dr. Richards' experience in multidisciplinary translational sleep and aging research spans more than 25 years and the results of her research are disseminated in more than 100 publications. She has conducted randomized controlled clinical trials of interventions, such as exercise and individualized social activity programs, resulting in large, clinically significant

improvements in sleep and other debilitating symptoms in institutionalized and hospitalized older adults. She has developed and validated measures, including a measure of sleep quality for use in critically ill older adults that has been translated into 12 languages, and a restless leg syndrome diagnostic tool for use in persons with cognitive impairment. Dr. Richards has conducted studies that have illuminated relationships between sleep disorders, such as restless legs syndrome, and behavioral symptoms, such as wandering, in community-dwelling older adults with cognitive impairment. Her program of research has advanced the science regarding design of clinical trials to test the efficacy of tailored, patient-centered interventions. She is the recipient of outstanding alumni awards from the University of Texas at Austin and the University of Arkansas for Medical Sciences. She is a fellow of the American Academy of Nursing and a fellow of the American Academy of Sleep Medicine.

040 Striking A Balance: Understanding Pain Management and Opioids

#### Wendy Wright, DNP, ANP-BC, FNP-BC, FAANP, FAAN, FNAP

There is a need for advanced practice nurses to increase their knowledge and skills regarding the latest evidence for understanding pain management and opioids and to apply that information to their practices to improve their patient outcomes. This newly updated course is designed to meet the FDA's Opioid Analgesic REMS.

**CO\*RE Case-Based Curriculum:** Our case-based session delivers a real-world educational experience through a series of cases and supporting content mapped to segments of the FDA Blueprint. This allows faculty to teach the application of concepts, fostering an engaging approach to pain management education.

By the end of this session, the learner will be able to describe the pathophysiology of pain as it relates to the concepts of pain management, accurately assess patients in pain, develop a safe and effective pain treatment plan, identify evidence-based non-opioid options for the treatment of pain, identify the risks and benefits of opioid therapy, manage ongoing opioid therapy, and recognize behaviors that may be associated with opioid use disorder.

The course curriculum is fully compliant with the FDA's September 2018 FDA Blueprint for Opioid Analgesic REMS Education\_and the 2022 Centers for Disease Control and Prevention (CDC) Clinical Practice Guideline for Prescribing Opioids for Pain. This session also meets many states' requirements for controlled substances CE.

The curriculum was developed by the Collaborative for REMS Education (CO\*RE) <a href="http://core-rems.org">http://core-rems.org</a> and is supported by an independent educational grant from the Opioid Analgesic REMS Program Companies (RPC).
